- 1. Set-up Of Booths Begins At 6:00AM And Must Be Completed By 8:00AM NO Vehicles Will Be Allowed In Festival Area After 7:45AM
- 2. Only First Quality Hand-Crafted Work Will Be Accepted. NO "Flea Market" Or Mass-Produced Items Will Be Allowed. NO Guns, Knives Or Fireworks. This is a juried event.
- 3. ALL Spaces Are 12'x12'. If You Need More Than This Amount, You Must Rent Two Spaces.
- 4. Tables Must Be Attractive And Boxes Kept Out Of Sight. Crafters Must Unload Their Items And Then Move Any Vehicles To The Designated Area Prior To Setting Up The Display. This Will Help To Keep The Streets From Being Congested And Help Traffic Move Easier. Sidewalks Must Remain Clear At All Times.
- 5. Water/Electricity Are Not Available To Crafters
- 6. Restrooms Will Be Available. Please Do Not Ask To Use The Facilities Of Retail Shops.
- 7. We Request That You Do Not Pack To Leave Until 5PM.
- 8. <u>Please Do Not Request To Be Assigned To A "Certain Area". Spaces Are Assigned According To Locations That Make The Festival More Guest Friendly.</u>
